**ORDER GRANTING THE CITY’S PLEA TO THE JURISDICTION**

The Court, after considering the City of Amarillo’s Plea to the Jurisdiction, the Intervenor’s Response, the remaining pleadings, and the evidence, the Court finds it does not have jurisdiction over (i) Intervenor’s claim that the debt service on the Notes is not properly characterized as “debt” under Tax Code 26.012 or (ii) Intervenor’s claim that the City violated Chapter 26 of the Tax Code by not providing notice and holding a hearing when Ordinance 7985 was adopted. The Court therefore finds the City’s Plea to the Jurisdiction should be GRANTED.

It is, therefore, ORDERED that the motion is GRANTED in all respects.
