Kimberley Allen, who serves as a Director, CFO, and Secretary of Power the Vote, Inc. is also campaign treasurer for Power the Vote- Texas, Inc. (GPAC).

The GTA form filed by Power the Vote- Texas, Inc. designates Allen as the sole contribution and expenditure decisionmaker for Power the Vote- Texas, Inc.


